# Join the Voting Game—Don't be a Spectator By Jan Corn, President

A dear friend of mine wears a button pin that says: "Democracy Isn't a Spectator Sport." Nothing could be more true. We are so fortunate to live in a country where we have the right to vote and elect our government decision-makers. We need to honor that right. We can't afford to be spectators in elections when so many important issues are at risk. We must get out to vote and make the best election choices for ourselves, public education, and our families. We all must educate ourselves on the issues and where each candidate stands on those issues.

In this light, the Alliance for Retired Americans (ARA) recently published a 2021 Congressional Voting Record which scored each U.S. Senator and Representative on critical retirement issues. Forty-two members of the U.S. Senate and 218 members of the House of Representatives earned perfect 100% scores. Fifty Senators earned scores of 20% or below. One hundred sixty-seven House members earned a score of 0%. Our New York representatives, Chuck Schumer and Kirsten Gillibrand, had perfect 100% scores as did every Democrat from NYS in the House of Representatives. This voting record is a valuable tool for us as we consider who to vote for in the next election. Also, on August 10, 2022, NYSUT issued a round of endorsements in state and federal campaigns. Go to https://www.nysut.org/news/2022/august/primary for this information. The full slate of state legislative endorsements and congressional endorsement recommendations are on this site. These candidates receive support from NYSUT members such as phone banking, door knocking, and literature endorsements. The union makes financial contributions from voluntary donations through the VOTE-COPE non-partisan political action committee as well.

We need to be vigilant in finding candidates that support our union principles of pension security, health benefit equity, fair wages, and Social Security and Medicare for all retired workers. Once we find these candidates, we need to help them get elected. We can make contributions to their campaigns, write postcards, make phone calls or send texts. Check with their campaign offices. We can also just "spread the word" to our families, neighbors, and friends.

Please don't be a spectator in the upcoming election. Our futures depend on our involvement!

# Sleep in Heavenly Peace

Earlier this year RC 8 learned that a local organization needed help, and as you can see from the above donation list, your participation fee was once again put to good use.

Sleep in Heavenly Peace (SHP) is a national organization with chapters all over the country including one right here in Oneida County and is led by Steve Sperbeck. They are an all-volunteer group who build bunk beds for kids sleeping on the floor, and their motto is *No Kid Sleeps on the Floor in Our Town!* 

Since their inception they have delivered 330 handmade beds. "Builds" take place at Meyda Tiffany in Yorkville, and everyone can get involved by helping make the beds, delivering the beds or making a financial donation for materials. In fact, some community groups have contributed sheets and blankets while a group of quilters has donated beautiful handmade quilts.

# **Earnings Legislation**

The law has changed as to how much we can earn in retirement working in a public school for this school year. Most schools still need teachers, so you might consider teaching again to help out during this critical time.

Sections 211 and 212 of the Retirement and Social Security Law govern NYS public employment by service retirees under age 65. Working under Section 211 requires your employer to obtain a waiver. The current Section 212 earnings limit, determined by the state Legislature, is \$35,000 per calendar year.

The earnings limit was temporarily suspended by New York State executive order during the COVID-19 pandemic, which resulted in no earnings limit for pay earned:

- From March 27, 2020, through December 31, 2020.
- From January 1, 2021, through June 24, 2021. (The governor rescinded the executive order effective June 25, 2021; therefore, pay earned from June 25, 2021, through September 26, 2021, counts toward the annual \$35,000 earnings limit.)
- From September 27, 2021, through August 28, 2022.

Newly enacted legislation, <u>Chapter 56 of the Laws of 2022</u>, extends the retirement earnings cap suspension through June 30, 2023. The new law only applies to retirees who return to work at a public school district or BOCES. Employment at a charter school, community college, SUNY, or any other public employment is not covered by this law. If interested please call Amber Dennis at 607 335-1255.
